FY2013 Tax Rate: \$15.33 (effective 1/1/12)	

The Town of Kingston, Massachusetts has numerous recorded liens on properties for Septic (Title V) or Sewer Hookup Loans and for Sewer Betterment Assessments.

Loans are required to be paid in full at time of **refinance** or **sale of a property**.

Unlike loans, a **Sewer Betterment** lien is not required to be paid in full and may Remain with the property. Be aware, the Town will not subordinate this lien.

For better maintenance of issued Municipal Lien Certificates, the following information is being provided to you to (first) expedite the process to issue you a certificate by providing all the required information and (secondly) to assure the requested monies are received by the Town of Kingston in a timely manner.
